Youth Group camping is done by advance reservation only. The camping area is for tent camping only, by organized youth groups - with the majority of members 17 years of age or less. **The Youth Group camping area is for youth and leaders only - not for families.** If a parent is required to camp with a youth, then there must be more youth than adults in the group to use the area. Any family groups posing as youth groups will not be allowed to camp in the youth area even if they have obtained a reservation.

All groups must be supervised by adults at all times, state curfew laws apply to any minors. The Youth Group campground is somewhat separated from the family campgrounds. **The reservation fee is \$5.00 for each group camp reservation.** *A reservation and reservation fee must be received by the park seven (7) days in advance of the camping date.* **Camping fees are \$1.00 per person, per night, with a minimum of \$10.00 per group per night.** All scouts must have their Touring Permit.

Minors are not allowed to roam free after dark. They must be chaperoned and stay within the perimeter of the Youth Group camping area. The recreational shelter is for daytime activities only. There is absolutely no camping in or under this shelter. Only one camping vehicle is allowed in the camping area with your group. All other vehicles must remain in the gravel parking lot.

YOUTH GROUPS CANNOT CAMP IN THE REGULAR CAMPGROUND. Beginning January 2001, youth groups will not be allowed in the regular campground in accordance with IDNR Administrative Code 130. If the youth group area is full for the weekend requested, another weekend must be chosen.

Ground fires are allowed in the Youth Group Area. Wood is for sale at several locations near the campground and at some stores in Utica. **There is NO cutting trees within the park. NO wood may be collected for fires within the park.**

REGULATIONS

We hope you have an enjoyable visit at Starved Rock State Park. Regulations are only common sense and are designed for your safety and to protect the park environment. Quiet hours begin at 10pm and end at 7am. The campground closes at 11pm and traffic barriers allow emergency exits only. Police and Ambulance have keys to enter the campground. The Starved Rock State Park campgrounds are built and maintained to provide camping in a natural setting as part of the outdoor recreational experience. THIS AREA IS NOT FOR PARTIES OR OTHER NOISY NIGHTTIME ACTIVITIES. The individuals who violate park rules, particularly regarding noise levels, alcoholic beverage consumption, and closing hours will be arrested and/or evicted. *Remember*, all pets must be on a leash and attended at all times.
